



Custom Status Panel System

Deployment licensing

Prices and terms effective from April 2014

Use of the NightWing Custom Status Panel system and the accompanying implementation guide may be licensed for inclusion in private or commercial solutions.

Licensed users are provided with access to the supporting code and layout objects as well as detailed implementation notes that are not included in the preview demo. The result is a cost-effective and straightforward way to implement advanced record, preview and related record navigation in the FileMaker environment. The system is wholly native to FileMaker, requiring no plug-ins or external code.

Purchase of a license to use the Custom Status Panel system does not confer ownership of the code or copyright. The license pertains to the use of the system throughout multiple layouts of one or more specific end-user solutions, whether a single-user, hosted or distributed deployment (including runtime applications). There are two licensing options/levels, as follows:

A: The license fees for individual seats (up to a maximum of 32 seats):

Two component charges apply – a basic "flag fall" charge per solution plus a cost per seat

License Level/Component	Pricing
Basic license charge/flagfall per solution <i>plus</i>	US\$ 20.00
Cost per seat per solution (including the first seat)	US\$ 10.00

C: For licensing of 33 or more seats per solution, we offer a Site License options:

Site License Level/Component	Pricing
Site License (first solution per site or organization)	US\$ 350.00
Site License (second and subsequent solutions)	US\$ 175.00

Notes and License Terms

- A seat is defined as an instance of FileMaker Pro or FileMaker Go that will be used to access the solution, or in the case of WebDirect access, the max number of simultaneous connections to be supported.
- Licenses apply to the use of the Custom Status Panel system with any version(s) of FileMaker.
- Additional seats may be purchased at any time to extend an existing license.
- A single or multi-seat license may be upgraded to a solution site license by payment of the difference between the original license cost and the current site licence price.
- Non-profit entities are eligible for a 20% discount (documentation required).
- Bona-fide independent developers distributing custom, shrink-wrapped or vertical market solutions may apply for developer license pricing of US\$175.00 for one solution, US\$262.50 for two solutions or US\$350.00 for three or more solutions.
- NightWing Enterprises retains copyright of the code and IP of the Custom Status Panel system, and this should be acknowledged in the copyright notes for any solution in which it is used.
- Support, installation and/or customization services are not included above and, if required, should be purchased separately.

Instructions for Purchasing a License
