

UltraLog FileMaker Audit System Commercial and Business Applications licensing

Prices and terms effective from July 2019

Access to the (locked) UltraLog demo is free for private, promotional and educational (ie instructional) purposes. Access to the code and/or installation of the system for administration, research, commercial or business applications is subject to license.

Licensed users are provided with access to additional code and advanced implementation examples that are not included in the demo version. The NightWing UltraLog audit tracking system offers numerous advantages over other logging systems, while being both cost-effective and straightforward to implement. Advantages include seamless operation across the FileMaker platform on both served and local solutions, full FileMaker Go and WebDirect support, plus a level of integration, robustness and security not achievable via plug-in based systems.

Purchase of a license to use the UltraLog system does not confer ownership of the code or copyright. The license pertains to the use of the system throughout multiple tables of a specific end-user solution, whether a stand-alone, hosted or distributed deployment (including runtime applications). There are two licensing options/levels, as follows:

A: The license fees per seat (minimum of 4 up to a maximum of 32 seats):

Two component charges apply – a basic "flag fall" charge per solution plus a cost per seat

License Level/Component	Pricing
Basic license charge (per solution, includes up to four seats)	US\$ 180.00
Cost per additional seat per solution (i.e. fifth and subsequent seats)	US\$ 20.00

B: For licensing of 33 or more seats per solution, we offer a Site License options:

Site License Level/Component	Pricing
Site License (first solution per site or organization)	US\$ 760.00
Site License (second and subsequent solutions)	US\$ 380.00

Notes and License Terms

- A seat is defined as any instance of FileMaker Pro or FileMaker Go that will be used to access the solution at any time, or in the case of web access of any kind, the max number of simultaneous connections to be supported.
- Licenses apply to the use of the UltraLog system with any version(s) of FileMaker.
- Additional seats may be purchased at any time to extend an existing license.
- A per-seat license may be upgraded to a solution site license by payment of the difference between the original license cost and the applicable site licence price.
- Non-profit entities are eligible for a 20% discount (documentation required).
- Bona-fide independent developers distributing custom, shrink-wrapped or vertical market solutions may apply for developer license pricing of US\$380.00 for one solution, US\$570.00 for two solutions or US\$760.00 for three or more solutions.
- NightWing Enterprises retains copyright of the code and IP of the UltraLog system, and this should be attributed in the copyright notes for any solution in which it is used.
- Support, installation and/or customization services are not included above and, if required, should be purchased separately.
