



NightWing Booking System v3.x

Deployment Licensing

Prices and terms effective from May 2015

The NightWing Booking System may be licensed for private or commercial use, or for inclusion in existing FileMaker solutions.

Licensing may be on a per-seat basis (allowing a given number of user accounts), with site licensing available for 32 or more seats. Developer licensing (which provides a Full Access unlocked copy) is also offered.

The system is wholly native to FileMaker, requiring no plug-ins or external code. It is principally designed for use in FileMaker Pro (and on FileMaker Server) and can also be accessed via FileMaker Go and FileMaker WebDirect. (Note: drag and drop features are not available in Go and WebDirect.)

Purchase of a license to use the NightWing Booking System does not confer ownership of the code or copyright. The per-seat and site licensing pertains to the end-user use of the system. Developer licensing covers incorporation of the system code interface and supporting techniques within one or more end-user solutions, whether a single-user, hosted or distributed deployment (including runtime applications).

The three licensing options/levels, are as follows:

- A: **The license fees for individual seats per solution (up to a maximum of 31 seats):**
Two component charges apply – a basic "flag fall" charge per solution plus a cost per seat.

- B: **For licensing of 32 or more seats per solution, a Site License is available:**

Notes and License Terms

- Licenses apply to the use of the NightWing Booking System v3.x with any version(s) of FileMaker.
- Seats are defined as either the number of persons who will access the system or the number of devices from which it may be accessed (whichever is the lower number). User access via all supported methods (FileMaker Pro, FileMaker Go or FileMaker WebDirect) is included in the seat count.
- Additional seats may be purchased at any time to extend an existing license. A single or multi-seat license may be upgraded to a solution site license by payment of the difference between the original license cost and the site licence price.
- Registered non-profit entities purchasing per seat or site licensing are eligible for a 20% discount (documentation required). Please note that developer licensing is not eligible for the non-profit discount.
- NightWing Enterprises Pty Ltd retains copyright of the code and IP of the NightWing Booking System, and this should be acknowledged in the copyright notes for any solutions in which it is used.
- Support, installation and/or customization services are not included above and, if required, should be purchased separately.

Instructions for Purchasing a License

- After your payment is confirmed, your license application will be processed and a license code will be emailed to you, usually within 24 hours.
